

History of NWICO



- 1970s NAM and the reform of UNESCO, cultural imperialism challenged
- National identity, pol and eco sovereignty,
 - The "free flow" doctrine of information flow, which was reinforcing the dominance of western media and news content;
 - The growing concentration of the media and communication industry translating into more foreign ownership of media in smaller and poorer countries;
 - How the growing importance of western controlled technologies to media production and dissemination was making it difficult for others to keep up.

The Rise and Demise of NWICO



- FoE meaningless with cultural imperialism of information flows
- Need for positive and collective rights
- US, UK and private media industries walk out

CR resurfaces



- Late 90s and IS politics strong CS movement - creating and environment in which freedom of expression maybe fully consummated.
- Enabling rights From Right to Communicate to CR., a set of rights

Communication Rights



- A right to participate in one's own culture, and use one 's mother language,
- including ethnic, religious or linguistic minorities;
- A right to information regarding governance and matters of public interest (freedom
- A right to the protection of the moral and material interests of authorship;
- A right to one's honour and reputation, and to protection against attacks;
- A right to privacy;
- A right to peaceful assembly and association;
- A right to free primary education and progressive introduction of free secondary education.

WSIS, CR and hijacked agenda


- WSIS CR movement finds no traction

 - The US sabotages policy outcomes at WSIS – NO GLOBAL POLICY ARCHITECTURE FOR THE INTERNET

- CS actors and Californian ideologies ICT utopia, geek-techie approaches and a deep animosity towards governments.
- Individualistic, and ahistorical in their position and against any conception of enabling rights.
- CR movement finds no favourable vibes in digital age progressive politics
