

10. Chatar Singh | Member, Mazdoor Kisan Shakti Sangathan



He runs an E-Mitra Kendra (i.e. a Citizen Service Center) in Bhim, Rajasthan where he facilitates people, particularly those from disadvantaged communities—including persons with disabilities, Dalits, Adivasis, the elderly, and single women—in accessing government schemes, applying for benefits, and filing grievances. Based on his daily work, he has a precise understanding of how citizens are both empowered and disempowered, at the intersection of digital technology and rights. He has been a part of the statewide and national campaign to demand an accountability law and has been a part of a large collective effort to demand an accountability for the denial of people's rights due to the arbitrary and undemocratic use of digital technologies.

23. Mansi Kedia | Senior Fellow, Indian Council for Research on International Economic Relations



31. Rakshita Swamy | Founder and Director, Social Accountability Forum for Action and Research



37. Tanuj Bhojwani | Independent


